Instructions for preparing apparatus

These instructions give details of the apparatus required by each candidate for each experiment in this paper. A summary of the questions that will be presented to the candidates is included, where appropriate, to allow the Biology teacher to test the apparatus appropriately. **No access to the question paper is permitted in advance of the examination.** Centres are reminded that candidates are expected to follow the instructions on the question paper and record all their results. They will not be penalised if these results are not what they expect.

The Supervisor should make sure the Supervisor's report is fully completed and a copy is enclosed with each packet of scripts.

If a candidate breaks any of the apparatus, or loses any of the material supplied, the matter should be rectified and a note made in the Supervisor's Report.

Candidates must be provided with a microscope with:

- Low-power objective lens, e.g. \times 10 (equal to 16 mm or $\frac{2}{3}$ ")
- High-power objective lens, e.g. \times 40 (equal to 4 mm or $\frac{1}{6}$ ")
- Eyepiece graticule fitted within the eyepiece and visible in focus at the same time as the specimen.

Each candidate must have sole, uninterrupted, use of the microscope for at least 55 minutes.

Supervisors are advised to remind candidates that **all** substances in the examination should be treated with caution. Pipette fillers and safety goggles should be used where necessary.

In accordance with the COSHH (Control of Substances Hazardous to Health) Regulations, operative in the UK, a hazard appraisal of the examination has been carried out.

The following codes are used where relevant.

C = corrosive substance	F = highly flammable substance
\mathbf{H} = harmful or irritating substance	O = oxidising substance
T = toxic substance	N = harmful to environment

Centres are reminded that they are **not** permitted to open the question paper envelopes before the examination. Confidential Instructions

Each candidate will require

Question 1

Fresh S, A, B, D and W are needed for each candidate. More of the solutions should be available if requested by candidates. Solutions and reagents provided to the candidates should be supplied in a suitable beaker, or container, for removal of the solution using a syringe.

(i) **S**, at least 200 cm^3 of 1 mol dm^{-3} sucrose solution, in a beaker or container, labelled **S**.

This is prepared by dissolving 68g of sucrose in $100 \, \text{cm}^3$ of distilled water and making up to $200 \, \text{cm}^3$ with distilled water.

(ii) A, at least 10 cm^3 of 0.7 mol dm^{-3} sucrose solution, in a small beaker or container, labelled A.

This is prepared by dissolving 48g of sucrose in $80\,\text{cm}^3$ and making up to $200\,\text{cm}^3$ with distilled water.

(iii) **B**, at least 10 cm³ of 0.25 mol dm⁻³ sucrose solution, in a small beaker or container, labelled **B**.

This is prepared by dissolving 17g of sucrose in $80\,\text{cm}^3$ and making up to $200\,\text{cm}^3$ with distilled water.

[H] (iv) D, at least 10 cm³ of 0.01% methylene blue solution, in a small beaker or container, labelled **D**.

This is prepared by dissolving 1 g of methylene blue in a container and making up to 100 cm³ with distilled water. This forms a 1% methylene blue solution.

Then take 1 cm³ of this solution and make up to 100 cm³ with distilled water.

Methylene blue is **harmful** and will stain skin. Care should be taken when making up the stain.

(v) W, at least 200 cm^3 of distilled water, in a beaker or container, labelled W.

It is advisable to wear safety glasses/goggles when handling chemicals.

Apparatus:

- (i) Two 10 cm^3 syringes or one 10 cm^3 syringe and one 50 cm^3 measuring cylinder.
- (ii) At least two 5 cm³ syringes. If possible, up to six 5 cm³ syringes can be provided.
- (iii) Container with tap water, labelled For washing.
- (iv) Container, labelled For waste.
- (v) Paper towels.
- (vi) Eight small containers capable of holding at least 50 cm³.
- (vii) One large test-tube, with the means to wash it out.
- (viii) Small Petri dish or shallow container.
 - (ix) Teat pipette.
 - (x) Test-tube rack or container to hold the large test-tube.
 - (xi) Glass marker pen.
- (xii) Safety goggles/glasses.

The Supervisor should, **out of sight of the candidates**, carry out **Question 1** and write the **results** in the Supervisor's report which should be enclosed with the candidates' scripts. Please ensure that if the scripts are in several packets that a copy of the Supervisor's report is enclosed with each packet of scripts. The invigilator should **not** carry out **Question 1**.

Question 2

- (i) Slide L1 (from Cambridge).
- (ii) Microscope with:
 - Low-power objective lens, e.g. \times 10 (equal to 16 mm or $\frac{2''}{3}$)
 - High-power objective lens, e.g. \times 40 (equal to 4 mm or $\frac{1}{6}$ ")
 - Eyepiece graticule (from Cambridge) fitted within the eyepiece and visible in focus at the same time as the specimen.

On receipt of the slides, please check that they are labelled L1 and that all slides are intact. The identity of material on the slides is **confidential** and must **not** be disclosed to candidates.

Each candidate must have sole, uninterrupted use of the microscope for 55 minutes.

The number of slides supplied by Cambridge will be equal to half the candidate entry. Therefore, half of the candidates should start **Question 1** and the other half should start on **Question 2**.

RETURN OF EXAMINATION MATERIALS TO CAMBRIDGE

Immediately after the examination the microscope slides must be:
