

Instructions for preparing apparatus

These Instructions give details of the apparatus required by each candidate for each experiment in this paper. A summary of the questions that will be presented to the candidates is included, where appropriate, to allow the Biology teacher to test the apparatus appropriately.

No access to the question paper is permitted in advance of the examination.

If a candidate breaks any of the apparatus, or loses any of the material supplied, the matter should be rectified and a note made in the Supervisor's Report.

Candidates must be provided with a microscope with:

- Eyepiece lens, $\times 10$ (equal to 16 mm or $\frac{2}{3}$ ")
- Low-power objective lens, $\times 10$ (equal to 16 mm or $\frac{2^{n}}{3}$)
- High-power objective lens, $\times 40$ (equal to 4 mm or $\frac{1}{6}$ ")
- Eyepiece graticule fitted within the eyepiece and visible in focus at the same time as the specimen.

To avoid confusion, Cambridge request that only the lenses specified above are fitted in the microscopes to be used in the examination. Any lenses which are **not** $\times 10$ or $\times 40$ should be removed or replaced.

Each candidate must have sole, uninterrupted, use of the microscope for at least 55 minutes.

Supervisors are advised to remind candidates that **all** substances in the examination should be treated with caution. Pipette fillers and safety goggles should be used where necessary.

In accordance with the COSHH (Control of Substances Hazardous to Health) Regulations, operative in the UK, a hazard appraisal of the examination has been carried out.

The following codes are used where relevant.

C = corrosive substance

H = harmful or irritating substance

T = toxic substance

- **F** = highly flammable substance
- **O** = oxidising substance
- **N** = harmful to environment

It is expected that the test-tubes provided are approximately 150 mm in height.

Other dimensions will be specified if needed in the Apparatus list.

Centres are reminded that they are **not** permitted to open the question paper envelopes before the examination. Centres should also refer to the Handbook for Centres.

Confidential Instructions

Each candidate will require:

For both questions

• mm ruler.

Question 1

- Solutions and reagents provided to the candidates should be supplied in a suitable beaker, or container, for removal of the solution using a syringe. More of the solutions should be available if requested by candidates.
- Clean test-tubes and syringes are needed for each candidate.
- Fresh C, W, M, and E and are needed for each candidate.
- All solutions and milk should be disposed of according to local safety regulations.

Summary of solutions:

labelled	contents	hazard	volume /cm ³
с	10% calcium chloride solution	[H] irritant	at least 50
w	distilled water	none	at least 100
М	milk	none	at least 100
E	1% rennet solution	[H] irritant	at least 20

It is advisable to wear safety glasses/goggles and gloves when handling chemicals.

Preparation of solutions:

[H] (i) C, at least 50 cm³ of 10% calcium chloride solution, in a beaker or container, labelled C.

This is prepared by putting 10 g of calcium chloride-6-water into 70 cm³ of distilled water and mixing continuously. Make up to 100 cm³ with distilled water.

This is sufficient for 2 candidates. The candidates will be told that this 10% solution is, for the purpose of their investigation, 20% calcium chloride.

(ii) W, at least 100 cm^3 of distilled water, in a beaker or container, labelled W.

This is sufficient for 1 candidate.

(iii) M, 100 cm³ of fresh full fat milk, in a beaker or container, labelled M. Or
Dried milk solution, in a beaker or container, labelled M.

The dried milk solution is prepared by putting 10g of dried milk powder in 80 cm³ distilled water, mixing continuously. Make up to 100 cm³ with distilled water.

This is sufficient for 1 candidate.

[H] (iv) E, at least 20 cm³ of 1% rennet solution, in a beaker or container, labelled E.

This is prepared by putting 1 cm³ of rennet solution (supplied by Cambridge) into 80 cm³ of distilled water and stirring continuously. Make up to 100 cm³ with distilled water.

This is sufficient for 5 candidates.

C, **M** and **E** can be made up the day before the examination and stored in a refrigerator. However, these must be at room temperature for the examination.

Apparatus for each group of candidates should be clean.

Syringe needles are **not** required and must **not** be given to candidates.

During the examination, the Supervisor (**not** the Invigilator) should, **out of the sight of the candidates**, carry out **Question 1** using the same solutions and reagents as the candidates. The results for **1(a)(ii)** should be written in the Supervisor's Report (on pages 7 and 8), not on a spare question paper. The Supervisor's Report and the candidates' seating plan should be enclosed with the candidates'

scripts.

Please ensure that, if the scripts are in several packets a copy of the Supervisor's Report and the candidates' seating plan are enclosed with each packet of scripts.

The Invigilator should not carry out Question 1.

Question 2

On receipt of the slides, please check that they are labelled **L1** and that none of the slides are broken. The material is **confidential** (so must **not** be disclosed to candidates) and the slides should **not** be viewed in advance of the examination.

The number of slides supplied by Cambridge will be equal to half the candidate entry. Therefore, half the candidates should start on **Question 1** and the other half should start on **Question 2**.

For each candidate:

- the microscope must be set up on low power
- the slide must **not** be on the stage of the microscope.
- Each candidate must have sole, uninterrupted use of the microscope for 55 minutes.
- (i) Slide L1 (supplied by Cambridge).
- (ii) Microscope with:
 - Low-power objective lens, $\times 10$ (equal to 16 mm or $\frac{2^{n}}{3}$)
 - High-power objective lens, $\times 40$ (equal to 4 mm or $\frac{1''}{6}$)
 - Eyepiece lens, $\times 10$ (equal to 16 mm or $\frac{2}{3}$ ")
 - Eyepiece graticule fitted within the eyepiece and visible in focus at the same time as the specimen.

To avoid confusion, Cambridge request that only the lenses specified above are fitted in the microscopes to be used in the examination. Any lenses which are **not** \times 10 or \times 40 should be removed or replaced.

RETURN OF EXAMINATION MATERIALS TO CAMBRIDGE

Immediately after the examination the microscope slides must be:

- returned to Cambridge in the containers in which they were received, using the self-adhesive label. These must **not** be included in the packet of scripts.
- Or
- purchased using the order form enclosed with the slides, which should be completed and returned to Cambridge. The order form must **not** be included in the packet of scripts.

Slides and boxes will be charged at the rate of £3 per slide and £1 per box.

If the items are not returned or purchased by the deadline stated on the order form they will be charged at £3.50 per slide plus £1 per box.

The Teacher responsible for the examination is asked to fill in the Supervisor's Report in these Confidential Instructions. For Centres where more than one script packet is used, there must be a copy of the completed Supervisor's Report and the candidates' seating plan in each script packet.

SUPERVISOR'S REPORT ON PRACTICAL BIOLOGY A LEVEL

The Supervisor or Teacher responsible for the subject should provide the following information.

1. Was any difficulty experienced in providing the necessary materials? If so, give brief details.

- 2. Give details of any difficulties experienced by particular candidates, giving names and candidate numbers. Reference should be made to:
 - (a) difficulties arising from faulty specimens or microscopes;
 - (b) accidents to apparatus or materials;
 - (c) assistance provided in case of colour-blindness;
 - (d) any other information that is likely to assist the Examiner, especially if this cannot be discovered from the scripts.

All other cases of individual hardship, e.g. illness or disability, should be reported direct to CIE on the normal 'Special Consideration Form' as detailed in the Handbook for Centres.

3. During the examination, the Supervisor should, out of sight of the candidates, carry out Question 1 using the same solutions and reagents as the candidates.
