### Instructions for preparing apparatus

These instructions give details of the apparatus required by each candidate for each experiment in this paper. A summary of the questions that will be presented to the candidates is included, where appropriate, to allow the Biology teacher to test the apparatus appropriately. **No access to the question paper is permitted in advance of the examination.** 

If a candidate breaks any of the apparatus, or loses any of the material supplied, the matter should be rectified and a note made in the Supervisor's Report.

Candidates must be provided with a microscope with:

- Eyepiece lens,  $\times 10$  (equal to 16 mm or  $\frac{2}{3}$ ")
- Low-power objective lens,  $\times 10$  (equal to 16 mm or  $\frac{2"}{3}$ )
- High-power objective lens,  $\times 40$  (equal to 4 mm or  $\frac{1}{6}$ ")
- Eyepiece graticule fitted within the eyepiece and visible in focus at the same time as the specimen.

To avoid confusion, Cambridge request that only the lenses specified above are fitted in the microscopes to be used in the examination. Any lenses which are **not**  $\times 10$  or  $\times 40$  should be removed or replaced.

Each candidate must have sole, uninterrupted, use of the microscope for at least 55 minutes.

Supervisors are advised to remind candidates that **all** substances in the examination should be treated with caution. Pipette fillers and safety goggles should be used where necessary.

In accordance with the COSHH (Control of Substances Hazardous to Health) Regulations, operative in the UK, a hazard appraisal of the examination has been carried out.

The following codes are used where relevant.

<b>C</b> = corrosive substance	F = highly flammable substance
H = harmful or irritating substance	<b>O</b> = oxidising substance
T = toxic substance	N = harmful to environment

Centres are reminded that they are **not** permitted to open the question paper envelopes before the examination. Centres should also refer to the Handbook for Centres.

## **Confidential Instructions**

Each candidate will require:

### For both Questions

• mm ruler.

### **Question 1**

• Solutions and reagents provided to the candidates should be supplied in a suitable beaker, or container, for removal of the solution using a syringe. More of the solutions should be available if requested by candidates.

- Fresh test-tubes and syringes are needed for each candidate.
- Fresh, E, W and S are needed for each candidate.
- All solutions and reagents should be disposed of according to local safety regulations.

Summary of solutions and reagents:

labelled	contents	hazard	volume /cm <sup>3</sup>
E	0.5% protease solution	none	20
W	distilled water	none	50
S	0.25% milk (see instructions)	none	50

## It is advisable to wear safety glasses/goggles when handling chemicals.

Preparation of solutions:

(i) E, at least 20 cm<sup>3</sup> of 0.5% protease solution in a beaker or container, labelled E.

This is prepared by putting 0.5 g of protease (supplied by Cambridge) in a beaker or container and making up to 100 cm<sup>3</sup> with distilled water, mixing well.

This is sufficient quantity for 5 candidates.

Please note – this makes 0.5% E but candidates will be intentionally informed that it is 1% E.

The Supervisor should test the activity of the enzyme by putting  $1 \text{ cm}^3$  of **E** and  $3 \text{ cm}^3$  of **S** in a test-tube at a temperature of between 35 °C and 40 °C. The mixture should go clear between 10-20 seconds. If the time is longer than 20 seconds, repeat with 1 % E (note: at 1% concentration, **E** is an irritant).

- (ii) W, at least  $50 \text{ cm}^3$  of distilled water in a beaker or container, labelled W.
- (iii) **S**, at least 50 cm<sup>3</sup> of 0.25% dried milk solution in a beaker or container, labelled **S**.

This is prepared by dissolving 1 g of dried milk powder in  $50 \text{ cm}^3$  of distilled water, stirring and then making up to  $100 \text{ cm}^3$  with distilled water. This makes a 1% milk solution. 0.25% milk solution is prepared as below:

Mixing  $25 \text{ cm}^3$  of the 1% milk solution with  $75 \text{ cm}^3$  of distilled water makes  $100 \text{ cm}^3$  of 0.25% of **S**. This is sufficient quantity for 2 candidates.

Beaker or container to maintain a water-bath between $35^{\circ}$ C and $40^{\circ}$ C and to hold 6 test-tubes	1	
Water at about 50 °C in a beaker or container, labelled <b>hot water</b> The <b>Supervisor</b> may use a thermostatically-controlled water-bath to provide additional hot water if requested by candidates.	1	
Water at room temperature in a beaker or container, labelled cold water	1	
Thermometer –10°C to 110°C	1	
Beakers or containers to hold 20 cm <sup>3</sup> volume	5	
Test-tubes	6	
Test-tube rack or container to hold 6 test-tubes	1	
Test-tube holder to hold test-tubes	1	
Black card, approximately 15 cm × 20 cm	1	
Glass rod	1	
Scissors	1	
Stop-clock, stopwatch or sight of a clock with a second hand	1

During the examination, the Supervisor should, **out of the sight of the candidates**, carry out **Question 1** using the same solutions and reagents as the candidates. These results should be written in the Supervisor's Report (**not** on a spare question paper) which should be enclosed with the candidates' scripts. If the scripts are in several packets, please ensure that a copy of the Supervisor's Report is enclosed with each packet of scripts. The Invigilator should **not** carry out **Question 1**.

## **Question 2**

- (i) Slide M1 (supplied by Cambridge)
- (ii) Microscope with:
  - Eyepiece lens,  $\times 10$  (equal to 16 mm or  $\frac{2}{3}$ ")
  - Low-power objective lens,  $\times 10$  (equal to 16 mm or  $\frac{2}{3}$ ")
  - High-power objective lens,  $\times 40$  (equal to 4 mm or  $\frac{1}{6}$ )
  - Eyepiece graticule fitted within the eyepiece and visible in focus at the same time as the specimen.

On receipt of the slides, please check that they are labelled **M1** and that all the slides are intact. The identity of material on the slides is **confidential** and must **not** be disclosed to candidates.

Each candidate must have sole, uninterrupted use of the microscope for 55 minutes.

The number of slides supplied by Cambridge will be equal to half the candidate entry. Therefore, half of the candidates should start on **Question 1** and the other half should start on **Question 2**.

# RETURN OF EXAMINATION MATERIALS TO CAMBRIDGE

Immediately after the examination the microscope slides must be:

- returned to Cambridge in the containers in which they were received, using the self-adhesive label. They must **not** be included in the packet of scripts.
