General information about practical exams

Centres must follow the guidance on science practical exams given in the Cambridge Handbook.

Safety

Supervisors must follow national and local regulations relating to safety and first aid.

Only those procedures described in the question paper should be attempted.

Supervisors must inform candidates that materials and apparatus used in the exam should be treated with caution. Suitable eye protection should be used where necessary.

The following hazard codes are used in these confidential instructions, where relevant:

- **C** corrosive
- **HH** health hazard**F** flammable

- MH moderate hazard
- T acutely toxic
- O oxidising
- N hazardous to the aquatic environment

Hazard data sheets relating to substances used in this exam should be available from your chemical supplier.

Before the exam

- The packets containing the question papers must **not** be opened before the exam.
- It is assumed that standard school laboratory facilities, as indicated in the *Guide to Planning Practical Science*, will be available.
- Spare materials and apparatus for the tasks set must be available for candidates, if required.

During the exam

- It must be made clear to candidates at the start of the exam that they may request spare materials and apparatus for the tasks set.
- Where specified, the supervisor **must** perform the experiments and record the results as instructed. This must be done **out of sight** of the candidates, using the same materials and apparatus as the candidates.
- Any assistance provided to candidates must be recorded in the supervisor's report.
- If any materials or apparatus need to be replaced, for example, in the event of breakage or loss, this must be recorded in the supervisor's report.

After the exam

- The supervisor must complete a report for each practical session held and each laboratory used.
- Each packet of scripts returned to Cambridge International must contain the following items:
 - the scripts of the candidates specified on the barcode label provided
 - the supervisor's results relevant to these candidates
 - the supervisor's reports relevant to these candidates
 - seating plans for each practical session, referring to each candidate by candidate number
 - the attendance register.

Specific information for this practical exam

During the exam, the supervisor or other competent biologist (**not** the invigilator) should obtain the results specified on the supervisor's report by following the relevant steps in the question paper. The results should be recorded in the space provided on the supervisor's report.

Organisation of the exam

- Half the candidates should start on Question 1 and the other candidates should start on Question 2.
- For Question 2, each candidate must have uninterrupted use of a microscope for at least 55 minutes.

Materials to be supplied by Cambridge International

• Slide L1

On receipt of the slides, check that they are labelled **L1** and that no slides are broken. The slides should **not** be viewed in advance of the exam. The material on the slides is confidential and must **not** be disclosed to candidates.

The number of slides supplied by Cambridge International will be equal to half the candidate entry.

Return of slides to Cambridge International

Immediately after the exam, the slides must be:

• returned to Cambridge International in the boxes in which they were received, using the self-adhesive label supplied. The slides must **not** be included in the packet of scripts.

or

• purchased using the order form enclosed with the slides, which should be completed and returned to Cambridge International. The order form must **not** be included in the packet of scripts. Slides and boxes will be charged at the rate of £3.25 per slide plus £1 per box.

If the slides are not returned or purchased by the deadline stated on the order form, the charge will be ± 3.75 per slide plus ± 1 per box.

Materials and apparatus for Question 1

Each candidate will need:

10% ascorbic acid solution in a beaker or container, labelled A , provided at room temperature (see Preparation of materials)	at least 120 cm ³	
A block of agar, containing 0.1% DCPIP, in a Petri dish, labelled B (see Preparation of materials)	1	
10 cm ³ syringe	1	
Beakers, capacity 50–100 cm ³	5	
Container, capacity approximately 200 cm ³ , labelled For waste	1	
Blunt forceps	1	
Single-edged blade	1	
White tile	1	
A4 sheet of 2 mm graph paper	1

Ruler, mm	1	
Glass marker pen, permanent	1	
Paper towels	8	
Stop-clock or timer, showing seconds	1	
Suitable eye protection	1	

The agar, **B**, may be prepared the day before the exam and wrapped in a plastic bag or similar and kept in a refrigerator overnight.

The agar should be at room temperature before the start of the exam.

• **A**, 10% ascorbic acid solution

This is prepared by putting 10 g of ascorbic acid in 80 cm^3 of distilled water in a beaker and making up to 100 cm^3 with distilled water. Mix well.

• 0.1% DCPIP, 2,6-dichlorophenolindophenol

This is prepared by putting 1 g of DCPIP **[HH][MH][N]** into 80 cm³ of distilled water in a beaker and making up to 100 cm³ with distilled water. Mix well. This is 1% DCPIP.

Put 10 cm^3 of the 1% DCPIP solution in a beaker and make up to 100 cm^3 with distilled water. Mix well.

• **B**, agar block, containing 0.1% DCPIP

Put 15g of technical agar (**not** nutrient agar) into 500 cm^3 of distilled water and heat to dissolve the agar. Mix well and remove from the heat.

Put 30 cm³ of 0.1% DCPIP into 500 cm³ of hot agar and mix gently to produce an even blue colour.

Pour the agar into shallow, flat containers that are at least 2 cm in depth. Keep the agar in cool conditions to set firmly. These containers must be placed on a horizontal flat surface so that the agar sets to an even depth of greater than 1 cm.

Just before the exam, cut the agar into blocks measuring at least $6 \text{ cm} \times 4 \text{ cm} \times \text{depth}$. For each candidate, put one block ($6 \text{ cm} \times 4 \text{ cm} \times \text{depth}$) in a Petri dish, covered with a lid, labelled **B**.

Preparation of materials

Microscope

Any lenses which are **not** \times 10 or \times 40 should be removed or replaced. The eyepiece graticule must be visible and in focus at the same time as the specimen.

For each candidate:

- the microscope must be set up on low power
- the slide must **not** be on the stage of the microscope.
