

## General information about practical exams

Centres must follow the guidance on science practical exams given in the Cambridge Handbook.

## Safety

Supervisors must follow national and local regulations relating to safety and first aid.

Only those procedures described in the question paper should be attempted.

Supervisors must inform candidates that materials and apparatus used in the exam should be treated with caution. Suitable eye protection should be used where necessary.

Hazard data sheets relating to substances used in this exam should be available from your chemical supplier.

### Before the exam

- The packets containing the question papers must **not** be opened before the exam.
- It is assumed that standard school laboratory facilities, as indicated in the *Guide to Planning Practical Science*, will be available.
- Spare materials and apparatus for the tasks set must be available for candidates, if required.

## **During the exam**

- It must be made clear to candidates at the start of the exam that they may request spare materials and apparatus for the tasks set.
- Where specified, the supervisor must perform the experiments and record the results as instructed.
   This must be done out of sight of the candidates, using the same materials and apparatus as the candidates.
- Any assistance provided to candidates must be recorded in the supervisor's report.
- If any materials or apparatus need to be replaced, for example, in the event of breakage or loss, this must be recorded in the supervisor's report.

#### After the exam

- The supervisor must complete a report for each practical session held and each laboratory used.
- Each packet of scripts returned to Cambridge International must contain the following items:
  - the scripts of the candidates specified on the bar code label provided
  - the supervisor's results relevant to these candidates
  - the supervisor's reports relevant to these candidates
  - seating plans for each practical session, referring to each candidate by candidate number
  - the attendance register.

## Specific information for this practical exam

During the exam, the supervisor (**not** the invigilator) must do all the experiments and record the results on a spare copy of the question paper, clearly labelled 'supervisor's results'.

If chemicals are prepared in more than one batch, clearly labelled supervisor's results must be provided for each batch. The candidates using each batch must be listed on the supervisor's report.

## **Apparatus**

The apparatus listed must be provided to each candidate.

- $1 \times 50 \, \text{cm}^3$  measuring cylinder
- 1 × burette stand and clamp
- $2 \times 100 \, \text{cm}^3 \, \text{beaker}$
- 1 × funnel (for filling burette)
- 1 × white tile
- 1 × glass rod
- 1 x stop-clock to measure to an accuracy of 1 second
- 2 × teat/dropping pipette
- 1 × spatula
- 1 × Bunsen burner
- 1 × heat-proof mat
- 1 × test-tube holder
- 2 × boiling tube
- 1 × hard-glass test-tube
- 6 × test-tube\*
- 1 × test-tube rack
- 1 × wash bottle containing distilled water
- 1 × pen for labelling glassware

paper towels

red and blue litmus papers

aluminium foil

wooden splints

the apparatus normally used in the centre for use with limewater in testing for carbon dioxide

\*Candidates are expected to rinse and reuse test-tubes where possible.

Additional test-tubes should be available.

## Per five candidates

A bucket labelled **quenching bath** must be provided.

The bucket must contain 1 dm<sup>3</sup> of 5% sodium carbonate solution (made up by dissolving 50 g of Na<sub>2</sub>CO<sub>3</sub> [MH] or 135 g of Na<sub>2</sub>CO<sub>3</sub> •10H<sub>2</sub>O [MH] in 1 dm<sup>3</sup> of water) and universal indicator [F].

The supervisor must monitor the colour of the universal indicator **[F]** in each quenching bath to check that the solution has **not** become acidic. If the solution becomes acidic, the supervisor must add more 5% sodium carbonate solution to the quenching bath.

© Materials

Characterials

Characterials listed in the table must be provided to each candidate. Materials must be labelled only as specified in the 'label' column. The characteristic soft chemicals labelled with letter codes, e.g. FA 1, may be different from their descriptions in the question paper. Candidates must be the descriptions of the use the descriptions given in the question paper. For example, candidates may be supplied with sulfuric acid, labelled as FA 1, but be told in the question paper that FA 1 is phosphoric acid.

FA 1	120 cm <sup>3</sup>	$0.0200\mathrm{moldm^{-3}}$ potassium manganate(VII)	Dissolve $3.16g$ of KMnO $_4$ <b>[O][MH][HH][N]</b> in each dm $^3$ of solution.
FA 2 [MH]	120 cm <sup>3</sup>	0.0950 mol dm <sup>-3</sup> ammonium iron(II) sulfate	Dissolve $37.25g$ of $(NH_4)_2Fe(SO_4)_2 \cdot 6H_2O$ [WH] in each $dm^3$ of 1.0 moldm <sup>-3</sup> $H_2SO_4$ see preparation instructions in the current syllabus.  OR  Dissolve $14.43g$ of $FeSO_4$ [WH] OR $26.40g$ of $FeSO_4 \cdot 7H_2O$ [WH] in each $dm^3$ of 1.0 moldm <sup>-3</sup> $H_2SO_4$ [WH]. This solution must be freshly prepared.
FA 3 [MH]	120 cm <sup>3</sup>	1.0 mol dm <sup>-3</sup> sulfuric acid	See preparation instructions in the current syllabus.
FA 4	150 cm <sup>3</sup>	0.100 mol dm <sup>-3</sup> sodium thiosulfate	Dissolve $24.82\mathrm{g}$ of $\mathrm{Na_2S_2O_3} \bullet 5H_2\mathrm{O}$ or $15.82\mathrm{g}$ of $\mathrm{Na_2S_2O_3}$ in each $\mathrm{dm^3}$ of solution.
FA 5 [MH][C]	3.5g	sodium carbonate + sodium hydrogensulfate	Grind together a 1:1 mass ratio of $\mathrm{Na_2CO_3}$ <b>[MH]</b> : $\mathrm{NaHSO_4}$ <b>[MH][C]</b> using a pestle and mortar. Provide 3.5 $\pm$ 0.2g in a stoppered container. Hydrated sodium carbonate is <b>not</b> suitable.
FA 6	5cm <sup>3</sup>	0.2 mol dm <sup>-3</sup> ammonium chloride	Dissolve 10.7 g of NH <sub>4</sub> C $l$ [MH] in each dm <sup>3</sup> of solution.

Note: Small amounts of SO<sub>2</sub> [C][T], which can cause respiratory distress in some people, may be produced. The laboratory must be well ventilated.
