Generic Marking Principles

These general marking principles must be applied by all examiners when marking candidate answers. They should be applied alongside the specific content of the mark scheme or generic level descriptors for a question. Each question paper and mark scheme will also comply with these marking principles.

GENERIC MARKING PRINCIPLE 1:

Marks must be awarded in line with:

the specific content of the mark scheme or the generic level descriptors for the question the specific skills defined in the mark scheme or in the generic level descriptors for the question the standard of response required by a candidate as exemplified by the standardisation scripts.

GENERIC MARKING PRINCIPLE 2:

Marks awarded are always whole marks (not half marks, or other fractions).

GENERIC MARKING PRINCIPLE 3:

Marks must be awarded **positively**:

marks are awarded for correct/valid answers, as defined in the mark scheme. However, credit is given for valid answers which go beyond the scope of the syllabus and mark scheme, referring to your Team Leader as appropriate

marks are awarded when candidates clearly demonstrate what they know and can do marks are not deducted for errors

marks are not deducted for omissions

answers should only be judged on the quality of spelling, punctuation and grammar when these features are specifically assessed by the question as indicated by the mark scheme. The meaning, however, should be unambiguous.

GENERIC MARKING PRINCIPLE 4:

Rules must be applied consistently e.g. in situations where candidates have not followed instructions or in the application of generic level descriptors.

GENERIC MARKING PRINCIPLE 5:

Marks should be awarded using the full range of marks defined in the mark scheme for the question (however; the use of the full mark range may be limited according to the quality of the candidate responses seen).

GENERIC MARKING PRINCIPLE 6:

Marks awarded are based solely on the requirements as defined in the mark scheme. Marks should not be awarded with grade thresholds or grade descriptors in mind.

	non-fluency features of spontaneous speech: fillers, pauses, false starts, reformulations, for example: <i>yeah it was erm (.) it was really tough</i> some language features that are thought to be female language characteristics (e.g. co-operative overlaps, back-channel support) – Note: it is easy to over-state the significance of 'gendered' features structure of exchanges – co-operative overlaps and interruptions. For example, <i>Kirsty:</i> never mind not box again	
	Nicola: i know	
	<i>Kirsty:</i> <i>again</i> limited amount of support and feedback between participants – for example Nicola interjecting <i>yeah</i> reference to theories/theorists of language such as Robin Lakoff, Deborah Tannen, Deborah Cameron and Jennifer Coates inclusive v. exclusive speech	
	Stronger and more confident candidates are likely to appreciate the highly co- operative nature of this conversation, and to see that Nicola and Kirsty are trying to be as helpful, positive and informative as they can be. The conversation comes across as quite natural, although Kirsty is clearly in charge of the interview. They may also recognise the difference in the purpose of the rising intonation in Kirsty's and Nicola's utterances. If candidates pursue such lines of argument in a balanced and coherent way, they are likely to gain higher marks.

If candidates pursue such lines of argument in a balanced and coherent way, they are likely to gain higher marks.

	theorists and theories, such as Skinner (Behaviourism/reinforcement), Chomsky (language acquisition device), Piaget (cognitive development), Vygotsky, Bruner et al. the speakers' developmental stages, and evidence of their linguistic competence; mostly adult-like speech patterns non-fluency features of spontaneous speech – fillers, pauses, false starts, reformulations, for example: <i>its sort of (.) the opinions sort of</i> <i>changed slowly</i> use of slang and Americanisms, for example: <i>cool dudes</i> and <i>gonna</i> the structure of the exchanges: several fulfilled adjacency pairs, but with interruptions and overlaps	
	Stronger and more confident candidates may comment on the close relationship between the two girls and how both girls talk quite maturely in the ways they explain things. They may also comment on how April assumes the role of the more knowledgeable other. If they do so in a balanced and coherent way they are likely to gain high marks.
