#### **Generic Marking Principles**

These general marking principles must be applied by all examiners when marking candidate answers. They should be applied alongside the specific content of the mark scheme or generic level descriptors for a question. Each question paper and mark scheme will also comply with these marking principles.

#### **GENERIC MARKING PRINCIPLE 1:**

Marks must be awarded in line with:

the specific content of the mark scheme or the generic level descriptors for the question the specific skills defined in the mark scheme or in the generic level descriptors for the question the standard of response required by a candidate as exemplified by the standardisation scripts.

#### **GENERIC MARKING PRINCIPLE 2:**

Marks awarded are always whole marks (not half marks, or other fractions).

#### **GENERIC MARKING PRINCIPLE 3:**

### Marks must be awarded **positively**:

marks are awarded for correct/valid answers, as defined in the mark scheme. However, credit is given for valid answers which go beyond the scope of the syllabus and mark scheme, referring to your Team Leader as appropriate

marks are awarded when candidates clearly demonstrate what they know and can do

marks are not deducted for errors

marks are not deducted for omissions

answers should only be judged on the quality of spelling, punctuation and grammar when these features are specifically assessed by the question as indicated by the mark scheme. The meaning, however, should be unambiguous.

#### **GENERIC MARKING PRINCIPLE 4:**

Rules must be applied consistently e.g. in situations where candidates have not followed instructions or in the application of generic level descriptors.

2	Assess the strengths and weaknesses of the evidence given by the author in Document 1 to support his conclusion.  Use the levels-based marking opposite to credit marks. No set answer is expected and examiners should be flexible in their approach. Candidates may include some of the following:  Strengths The following strengths of evidence all strengthen the support for the author's conclusion that the MENA area should grasp the opportunities that the internet and social media bring:  Uses relevant evidence and examples to support the conclusion – The conclusion about grasping the opportunities is supported by relevant evidence and examples of successes, Just Falafel's expansion, growth of the mobile gaming industry in China and Turkey, Ahmed Sakr's successful career information gathering. Uses 2014 data from Deloitte in a document written in 2014.  Uses evidence from sources with authority – UN study on youth employment projections, Dubai school of government on jobseekers' attitudes to social media. This leads to confidence in what they say.  Uses a range of global evidence – Evidence is given about China, and Turkey, and from Dubai, which increases the context of the impact of the internet and social media.  Uses precise and relevant statistics – from Deloitte about potential 25% increase in productivity; about Just Falafel's increasing their initial investment in Facebook by 18 times; from the UN about the 29% expected increase in youth unemployment; from the Dubai school of Government about 71% of responses to using social media to find next jobs. This provides a precise background to build support for grasping the opportunities.  Uses historic perspective in the evidence – The argument accepts that people in the Arab world are already spending more time on mobile apps, before arguing about further opportunities for development. 3	Both authors present arguments about the impact of the internet and social media upon the Arab world in the MENA region.  To what extent is the author's argument in Document 2 stronger than that of the author in Document 1?  No set answer is expected and examiners should be flexible in their approach. Candidates may include some of the following:  Stronger  Less sweeping conclusion – Raqui Doc 2) is more cautious as he recognises that there are drastic changes – negative changes as well as positive; whereas Labin Doc (1) argues that the changes are positive and sustainable so the opportunities should be welcomed and grasped.  More balanced argument – Raqui (Doc 2) gives negatives as well as positives – the impact on gender relations in conservative countries (negative for the conservatives) and on family loyalty; whereas Labin (Doc 1) looks only at the positive impact on business and careers.  More academic – Raqui (Doc 2) uses the views of authors who have written books in the field e.g. Weeler and Rajani, Chandio and Eickelman; whereas Labin (Doc 1) presents unsourced claims from his own experience e.g. views of the people on Facebook about its impact; the numbers active on Facebook and in the MENA area; how Facebook can help SMEs; the growth of the mobile gaming industry in China and Turkey; how Just Falafel expanded; how Ahmed Sakr was successful with his Facebook search.  Wider perspectives/lenses – Raqui (Doc 2) looks at the impact upon gender relations, family loyalty and political activity; whereas Labin (Doc 1) mainly looks at the impact upon business. 	In doing this they might conclude that Dr Raqui's argument (Doc 2) is stronger because of more expert sources, a more balanced argument and a less sweeping conclusion.  Alternatively, they might conclude that overall, despite Labin's (Doc 1) narrower focus, his argument is stronger because of the relevant expertise he brings from his position in Facebook in the Middle East.  Credit should be given to any alternative judgement on the basis of the assessment and reasoning e.g. that both arguments are equally strong.
