(b) The author of Document B discusses the impact of universal healthcare on doctors.

Identify **two** financial impacts of introducing universal healthcare as given by the author of Document B. [2]

Assess the strengths and weaknesses of the evidence used by the authors of Document A to support their argument that universal health coverage is the key to pandemic management.

In your answer include the impact of the evidence on the authors' argument. [15]

3 Study Documents A and B.

The authors of the two documents present different arguments and perspectives on the impacts of universal healthcare.

Evaluate the arguments of the authors of both documents. In your answer, consider their perspectives and include a reasoned judgement about whether one argument is stronger than the other. [25]
