## Cambridge International AS & A Level – Mark Scheme PUBLISHED

#### **Generic Marking Principles**

These general marking principles must be applied by all examiners when marking candidate answers. They should be applied alongside the specific content of the mark scheme or generic level descriptors for a question. Each question paper and mark scheme will also comply with these marking principles.

#### **GENERIC MARKING PRINCIPLE 1:**

Marks must be awarded in line with:

- the specific content of the mark scheme or the generic level descriptors for the question
- the specific skills defined in the mark scheme or in the generic level descriptors for the question
- the standard of response required by a candidate as exemplified by the standardisation scripts.

#### **GENERIC MARKING PRINCIPLE 2:**

Marks awarded are always whole marks (not half marks, or other fractions).

#### **GENERIC MARKING PRINCIPLE 3:**

#### Marks must be awarded **positively**:

- marks are awarded for correct/valid answers, as defined in the mark scheme. However, credit
  is given for valid answers which go beyond the scope of the syllabus and mark scheme,
  referring to your Team Leader as appropriate
- marks are awarded when candidates clearly demonstrate what they know and can do
- marks are not deducted for errors
- marks are not deducted for omissions
- answers should only be judged on the quality of spelling, punctuation and grammar when these
  features are specifically assessed by the question as indicated by the mark scheme. The
  meaning, however, should be unambiguous.

#### **GENERIC MARKING PRINCIPLE 4:**

Rules must be applied consistently, e.g. in situations where candidates have not followed instructions or in the application of generic level descriptors.

#### **GENERIC MARKING PRINCIPLE 5:**

Marks should be awarded using the full range of marks defined in the mark scheme for the question (however; the use of the full mark range may be limited according to the quality of the candidate responses seen).

#### GENERIC MARKING PRINCIPLE 6:

Marks awarded are based solely on the requirements as defined in the mark scheme. Marks should not be awarded with grade thresholds or grade descriptors in mind.

## Task 1 - Graphics *Lens*



Bitmap (Background1) is cropped – similar to area shown in the question paper and fills the canvas.	1
A circle for the lens is drawn.	1
The circle has a black outline that matches the thickness shown in the question paper.	1
The proportion of the background covered by the circle matches the area shown in the question paper.	1
Handle is correct and to the edge.	1
The area inside the circle appears to be magnified. This must be for the whole lens and not a recreation of the background.	1
There is a degree of magnification that matches that shown in the question paper.	1
The text "Malwa" is the correct size and appears to be part of the magnified background.	1
Not all of the last 'a' in "Malwa" is visible.	1
the "Malwa" text is coloured red.	1
There are 2 'light blooms' with defined shapes but no outlines.	1
the 'light blooms' are in the correct positions as shown in the question paper.	1
the 'light blooms' are the correct shape (crescents) as shown in the question paper.	1
the blooms have the same proportions as those shown in the question paper.	1
the blooms are partially transparent.	1


## Task 2 - Vector Graphics

#### Clouds



The clouds overlap in the correct order.	1
The clouds have a clear thin black unbroken outline.	1
The clouds have a uniform light grey fill.	1
There is a darker grey underside to one cloud (with no outline) that matches the edge of the cloud as shown in the question paper.	1
There are darker grey undersides to both clouds (with no outlines) that match the edges of the clouds as shown in the question paper.	1
The clouds consist of a reasonable number of smooth convex lobes.	1
All three clouds have a very similar shape.	1
The image of the clouds has a transparent background.	1

#### Bolt



The image of the bolt tapers has a single outline and tapers as shown in the question paper.	1
The bolt has 3 tapering stages as shown in the question paper.	1
The bolt has accurate and parallel 'Z' angles.	1
The bolt has a gradient fill.	1
The gradient fill follows the shape of the bolt vertically and changes from red to yellow.	1
The image of the bolt has a transparent background.	1
Both images (Clouds and Bolt) are saved as .svg files.	1

# Task 3 – Animation *Malware – Zap*



The size of the animation is 500px by 400px.	1
The animation starts with the green background.	1
The green and black backgrounds alternate (seamlessly) 3 times before looping.	1
The green and black backgrounds alternate with regular 0.5 sec timings.	1
A portion of the clouds image is shown in the top left corner of the frame.	1
The clouds image is static throughout the animation.	1
The black background is showing when the bolt appears.	1
The bolt appears from behind the clouds image.	1
The bolt appears from behind the clouds image in one smooth movement.	1
The bolt continues to travel across the frame smoothly and in the correct straight line.	1
The bolt fully exits the frame smoothly.	1
The correct 'Malware' text is displayed,	1
The text "Malware" rises smoothly from the bottom to the correct level.	1
The text "Malware" fades in smoothly.	1
The text "Malware" and the image of the bolt cross paths.	1
The text "Malware" is fully visible as the paths cross.	1
The text "Malware" appears to explode as the image of the bolt touches the text.	1
The text "Malware" appears to explode into individual letters.	1
All the letters of the text appear to grow smoothly.	1
All the letters of the text appear to grow to at least twice their original size.	1
The individual letters of the text appear to explode in different directions with different orientations.	1
The letters of the text fade out.	1
Finally, only the clouds image on the black background is visible for one 0.5 second flash.	1





There are 3 merged cells in the 2nd row above with the same height as the squares in the grid.	1
All the internal borders of the cells are displayed.	1
The external borders of the grid are thicker than the internal borders.	1
Each cell in the grid will only accept Xs or 0s (Zero not O),	1
All cells have a yellow fill when X is entered.	1
All cells have a grey fill when 0 is entered.	1
All Xs and 0s are displayed in a red 72pt font.	1
All cells adjacent to the grid display blank for no entries.	1
Testing – 1 horizontal line win displays the correct results for X and 0.	1
Testing – all horizontal line wins display the correct results for X and 0.	1
Testing – all horizontal line wins display the correct results in correct cells.	1
Testing – 1 vertical line win displays the correct results for X or 0.	1
Testing – All vertical line wins display the correct results for X or 0.	1
Testing – All vertical line wins display the correct results in the correct cells.	1
Testing – Left/Right diagonal win displays the correct result for X or 0.	1
Testing – Right/Left diagonal win displays the correct result for X or 0.	1




