Section A

Answer Question 1.

Social surveys seek to collect information from a wide range of people. To achieve this, researchers will choose what they consider to be a suitable sampling technique to select a sample.

Social surveys usually use a sampling technique which aims for a highly representative sample, such as a stratified sample. Other research methods may use a sampling technique, such as a snowball sample, to select a particular group of people who may not be representative of the wider population. Sociologists use a variety of random and non-random sampling techniques. Social surveys usually collect quantitative data. Sociologists consider quantitative research methods to be high in *reliability*. Interpretivists, however, argue that the data produced may lack validity.

- (c) Explain why researchers are careful to select a suitable sampling technique when carrying out large scale social surveys. [8]
