

In response to the Covid-19 outbreak in 2020, airports worldwide increased their health screening and security procedures.

Governments in many countries restricted entry into the country and restricted movement between towns and cities in an attempt to control the outbreak and reduce the numbers of cases.

- Airline flights were grounded which had an impact on airlines and on many other tourism businesses.
- Airlines ran reduced flight schedules due to the Covid-19 outbreak.
- The Covid-19 virus caused an estimated 80% reduction in air travel.
- The decrease in global capacity was greater than after the 9/11 terrorist attacks in New York.
- Passengers became increasingly wary of flying.
- Travellers at some airports expressed concern about a lack of health screening at customs.


