How reliable is this source as evidence of everyday life for families during their journey west? Explain your answer using details from the source **and** your knowledge. [7]

### 4 Study Sources D and E.

Why do these sources differ in their accounts of the relationship between the emigrants traveling west and the Native Americans? Explain your answer using details from the sources **and** your knowledge. [10]

#### 5 Study all the sources.

"The most serious obstacle facing the emigrants who traveled west was the weather." To what extent do you agree? Explain your answer using details from all the sources **and** your knowledge.
