(a+b)^{n}=a^{n}+\binom{n}{1} a^{n-1} b+\binom{n}{2} a^{n-2} b^{2}+\ldots+\binom{n}{r} a^{n-r} b^{r}+\ldots+b^{n},
$$

where $n$ is a positive integer and $\binom{n}{r}=\frac{n!}{(n-r)!r!}$

1 (a) Given that $\mathscr{E}=\{x: 1<x<20\}$,

$$
\begin{aligned}
& A=\{\text { multiples of } 3\}, \\
& B=\{\text { multiples of } 4\},
\end{aligned}
$$

find
(i) $\mathrm{n}(A)$,
(ii) $\mathrm{n}(A \cap B)$.
(b) On the Venn diagram below, draw the sets $P, Q$ and $R$ such that $P \subset Q$ and $Q \cap R=\varnothing$.

(c) Using set notation, describe the shaded areas shown in the Venn diagrams below.

2 On the axes below, sketch the graph of the curve $y=\left|2 x^{2}-5 x-3\right|$, stating the coordinates of any points where the curve meets the coordinate axes.


3 (i) Find the first 3 terms in the expansion, in ascending powers of $x$, of $\left(3-\frac{x}{9}\right)^{6}$. Give the terms in their
simplest form.
(ii) Hence find the term independent of $x$ in the expansion of $\left(3-\frac{x}{9}\right)^{6}\left(x-\frac{2}{x}\right)^{2}$.

4 The polynomial $\mathrm{p}(x)=2 x^{3}+a x^{2}+b x-49$, where $a$ and $b$ are constants. When $\mathrm{p}^{\prime}(x)$ is divided by $x+3$ there is a remainder of -24 .
(i) Show that $6 a-b=78$.

It is given that $2 x-1$ is a factor of $\mathrm{p}(x)$.
(ii) Find the value of $a$ and of $b$.
(iii) Write $\mathrm{p}(x)$ in the form $(2 x-1) \mathrm{Q}(x)$, where $\mathrm{Q}(x)$ is a quadratic factor.
(iv) Hence factorise $\mathrm{p}(x)$ completely.

5 It is given that $\log _{4} x=p$. Giving your answer in its simplest form, find, in terms of $p$,
(i) $\quad \log _{4}(16 x)$,
(ii) $\quad \log _{4}\left(\frac{x^{7}}{256}\right)$.

Using your answers to parts (i) and (ii),
(iii) solve $\log _{4}(16 x)-\log _{4}\left(\frac{x^{7}}{256}\right)=5$, giving your answer correct to 2 decimal places.

6 (a) Given that $\mathbf{A}=\left(\begin{array}{rr}1 & 2 \\ 0 & -1\end{array}\right), \mathbf{B}=\left(\begin{array}{rr}1 & -4 \\ 2 & 5 \\ 3 & 1\end{array}\right)$ and $\mathbf{C}=\left(\begin{array}{lll}3 & -2 & 0\end{array}\right)$, write down the matrix products which are possible. You do not need to evaluate your products.
(b) It is given that $\mathbf{X}=\left(\begin{array}{rr}2 & -2 \\ 5 & 3\end{array}\right)$ and $\mathbf{Y}=\left(\begin{array}{ll}4 & 1 \\ 2 & 0\end{array}\right)$.
(i) Find $\mathbf{X}^{-1}$.
(ii) Hence find the matrix $\mathbf{Z}$ such that $\mathbf{X Z}=\mathbf{Y}$.

7 Do not use a calculator in this question.
All lengths in this question are in centimetres.


The diagram shows the trapezium $A B C D$, where $A B=2+3 \sqrt{5}, D C=6+3 \sqrt{5}, A D=10-2 \sqrt{5}$ and angle $A D C=90^{\circ}$.
(i) Find the area of $A B C D$, giving your answer in the form $a+b \sqrt{5}$, where $a$ and $b$ are integers.
(ii) Find $\cot B C D$, giving your answer in the form $c+d \sqrt{5}$, where $c$ and $d$ are fractions in their simplest form.

8 (a)


The diagram shows the velocity-time graph of a particle $P$ moving in a straight line with velocity $v \mathrm{~ms}^{-1}$ at time $t$ seconds after leaving a fixed point.
(i) Write down the value of the acceleration of $P$ when $t=5$.
(ii) Find the distance travelled by the particle $P$ between $t=0$ and $t=10$.
(b) A particle $Q$ moves such that its velocity, $v \mathrm{~ms}^{-1}, t$ seconds after leaving a fixed point, is given by $v=3 \sin 2 t-1$.
(i) Find the speed of $Q$ when $t=\frac{7 \pi}{12}$.
(ii) Find the least value of $t$ for which the acceleration of $Q$ is zero.

9 The area of a sector of a circle of radius $r \mathrm{~cm}$ is $36 \mathrm{~cm}^{2}$.
(i) Show that the perimeter, $P \mathrm{~cm}$, of the sector is such that $P=2 r+\frac{72}{r}$.
(ii) Hence, given that $r$ can vary, find the stationary value of $P$ and determine its nature.

10 A curve is such that when $x=0$, both $y=-5$ and $\frac{\mathrm{d} y}{\mathrm{~d} x}=10$. Given that $\frac{\mathrm{d}^{2} y}{\mathrm{~d}^{2}}=4 \mathrm{e}^{2 x}+3$, find (i) the equation of the curve,
(ii) the equation of the normal to the curve at the point where $x=\frac{1}{4}$.

11 (a) Solve $\sin x \cos x=\frac{1}{2} \tan x$ for $0^{\circ} \leqslant x \leqslant 180^{\circ}$.
(b) (i) Show that $\sec \theta-\frac{\sin \theta}{\cot \theta}=\cos \theta$.
(ii) Hence solve $\sec 3 \theta-\frac{\sin 3 \theta}{\cot 3 \theta}=\frac{1}{2}$ for $-\frac{2 \pi}{3} \leqslant \theta \leqslant \frac{2 \pi}{3}$, where $\theta$ is in radians.
