Show in your answer that you have considered more than one point of view. [8] [Total: 20] 2 (a) Describe the miracle involving the centurion's servant (**RSV** slave). [6] **(b)** Explain possible reasons for the actions of Jesus on this occasion. [6] (c) 'Miracles were not the most important part of Jesus' ministry.' To what extent do you agree? Show in your answer that you have considered more than one point of view. [Total: 20] 3 (a) Give an account of the parable of the Sower, including Jesus' explanation. [6] **(b)** Explain how the teaching in this parable might be relevant for Christians today. [6] (c) 'Jesus' parables are too difficult to understand.' To what extent do you agree? Show in your answer that you have considered more than one point of view. [8] [Total: 20] (a) Give an account of the parable of the Friend at Midnight. [6] **(b)** Explain what this story might teach about prayer. [6] (c) 'Prayers that make personal requests should be private.' To what extent do you agree?
